

New Issue – Cleansing Notice & Appendix 3B

Novita Healthcare Limited, (“Novita” or the “Company”) is pleased to advise the completion tomorrow of the Placement (Tranche 2) with the issue of 66,666,667 new shares at \$0.030 per share to raise \$2.0 million (before costs). The Placement (Tranches 1 & 2) was arranged and announced on 12 July 2017 and Tranche 2 approved at the Extraordinary General Meeting (EGM) of shareholder held on 18 August 2017. The two Tranches raised a total of \$2.5 million (before costs).

The Company will issue 66,666,667 ordinary shares (“Issue Shares”) on 23 August 2017 pursuant to the Appendix 3B attached to this announcement and as detailed in the Notice of EGM lodged with ASX on 19 July 2017.

The Company has issued the Issue Shares without disclosure to investors under section 708A(5) of the Corporations Act 2001 (Cth) (“Corporations Act”).

For the purposes of section 708A(6) of the Corporations Act, the Company advises:
