### TALI HEALTH PROGRESS UPDATE

Novita Healthcare Limited (ASX: NHL) (“**Novita**” or the “**Company**”) is pleased to provide an update on the progress of commercialisation of its breakthrough digital treatment solution, TALI Train, and on further developments in its research project, TALI Detect.

#### Highlights

- **Controlled commercial launch with a campaign targeting 108 clinicians primarily psychologists in Victoria**
- **Encouraging take up rate of 50% among targeted clinicians, with 54 becoming Certified TALI Train Providers**
- **National commercial roll-out of TALI Train commenced in April 2018**
- **First quarterly review of TALI Detect project completed, with progress report to be submitted to the Australian Federal Government**
- **TALI Health focused on the emerging digital therapeutics category**

#### TALI Train

The Company is pleased to report the progress on commercial launch of TALI Train over the last quarter.

TALI Train was commercially launched over a 7-week period (during February to March 2018) through a focused campaign targeting 108 clinicians primarily psychologists in Victoria. The Company is pleased to report highly encouraging engagement:

- 50% of the targeted clinicians (54 clinicians) have since become Certified TALI Train Providers, and are now able to deliver the TALI Train program to patients
- 25 TALI Train app licences have been purchased by these clinicians

The initial targeted launch enabled the Company to obtain valuable information in relation to uptake incentives and the effectiveness of its marketing strategy. The learning from the controlled launch will be leveraged for the national rollout of the program.

In April 2018, TALI Train was commercially released to the national market, with a focus on engaging clinicians Australia wide.

#### TALI Detect

During the previous quarter, Novita made pleasing progress on its research and development project, TALI Detect (a scalable detection tool for childhood attention disorders).

In January 2018, Novita initiated the TALI Detect project with its R&D partners. The Company was also awarded a A\$1.2m grant by the Australian Federal Government’s Cooperative Research Centre (CRC) to design, develop and commercialise TALI Detect (announced in December 2017).

The first quarterly review of the TALI Detect CRC project has now been completed, and a progress report will be submitted to the Government. Development on the TALI Detect CRC project is progressing as scheduled.

TALI Health's current and future solutions are focused on the emerging digital therapeutics category. Digital therapeutics (app-based solutions as an example) implement treatment programs tailored to specific conditions. Digital treatment solutions can be delivered at massive scale and low cost, and by helping to treat underlying conditions, can potentially improve health outcomes and the efficiency of the health sector.

Novita looks forward to providing the market with further progress updates with respect to the commercialisation of TALI Train, and on the research and development of the TALI Detect CRC project on a quarterly basis.
